In the reference 2<sup>nd</sup> cited, the **Chettinad Dental College & Research Institute, Kelambakkam, Kancheepuram District** has obtained the recognition order from the Under Secretary to the Government of India, Dental Council of India/ Ministry of Health and Family Welfare, New Delhi to conduct **BDS Degree Course**.

**ORDER**


