- 4. The Government after verifying the desirability and feasibility, convey permission / Essentiality Certificate to start the following 8 (Eight) MDS Courses from the academic year 2017-2018 with an annual intake noted against each of the courses, subject to the condition that norms of the Dental Council of India should be fulfilled and the deficiencies pointed out in the Inspection report should be rectified before the inspection of the Dental Council of India and also the approval of the Dental Council of India / Government of India, Ministry of Health and Family Welfare, New Delhi should be obtained before the students are admitted:-
