ORDER:

The Principal, Chettinad Dental College & Research Institute, Kelambakkam, Kancheepuram, has submitted the proposal to this University for issue of Letter of Consent of Affiliation for starting MDS Degree Course in the Speciality of Public Health Dentistry with an annual intake – 03 seats from the academic year 2020-2021.

- 2) In the reference second cited, based on the reports of the inspection Commission and DCI regulations, the necessary "Letter of Consent of Affiliation" was issued for starting of the above said one(1) new speciality in Public Health Dentistry MDS Degree Course with annual intake-03 seats mentioned against each at Chettinad Dental College & Research Institute, Kelambakkam, Kancheepuram, from the academic year 2020-2021, so as to apply the Dental Council of India for obtaining formal permission from the Government of India, New Delhi.
- 3) In the reference 4th cited, the Government of India, Ministry of Health and Family Welfare, New Delhi has conveyed the Letter of Permission of the Central Government vide in letter No **V.12017/12/2019-DE dt. 28.02.2020** for starting **M.D.S. Degree Course** in the following speciality at **Chettinad Dental College & Research Institute, Kelambakkam, Kancheepuram,** from the academic session 2020-2021 under Section 10(A) of the Dentists Act, 1948.

It is specified that this "the Permission of the Central Government is accorded initially for a period of one year and will be renewed on yearly basis subject to the verification of the achievement of annual targets as indicated in your scheme. The process of renewal of permission in the original intake capacity will continue till such time the expansion of its facilities is completed. Any admission made in violation of the above condition will be treated as irregular and action under the provisions of the Dentists Act, 1948 and Regulations made thereunder shall be taken".

- 4) On receipt of the Letter of Permission from the Government of India, Ministry of Health and Family Welfare, New Delhi, this University has constituted the Inspection commission to verify the infrastructural facilities including teaching staff at the above said institution to consider the issue of Provisional Affiliation for starting MDS Degree Course in the Speciality of Public Health Dentistry with an annual intake 03 seats from the academic year 2020-2021.
- 5) Accordingly, the Inspection Commission has conducted the Inspection and submitted their reports to this University, which has stated that the infrastructure, staff, equipments, clinical materials and Lab investigations are adequate **for starting MDS Degree Course in the Speciality of Public Health Dentistry with an annual intake 03 seats from the academic year 2020-2021**, with reference to Dental Council of India revised MDS Course regulation 2017.
- 6) In pursuance to the Resolution passed by the Governing Council, the permission granted by the Government of India, Ministry of Health & Family Welfare, New Delhi and based on the report of Inspection Commission, this University hereby grants the orders of **Provisional Affiliation** to **Chettinad Dental College & Research Institute, Kelambakkam, Kanchipuram District for starting MDS Degree Course in the Speciality of Public Health Dentistry with an annual intake 03 seats from the academic year 2020-2021.**
- 7) It is also informed that the institution should take up the matter for yearly basis renewal on till the original intake recognition by Dental Council of India / Central Government and subject to the conditions as mentioned in the annexure. Further, the institution is fully responsible to fulfill the norms of DCI, New Delhi.
- 8) The admission procedure of the Government as per the scheme of admission enunciated by the Supreme Court of India should be followed.
- 9) The Management shall follow transparent and reasonable method of admission for the Management quota as stipulated in the Government Orders in force.
- 10) Any other condition which the University consider necessary to impose from time to time should be followed.

11) The receipt of this proceeding be acknowledged.
